

It gives me great pleasure to present our inaugural annual report and our financial position for the past 21 months ending on the 31st March 2017.

Early in 2015, no less than 94% of our people ratified the governance entity to be known as Heretaunga Tamatea Settlement Trust. This entity, born out of He Toa Takitini, was therefore recognised by the Crown as the body to receive and manage the Treaty of Waitangi settlement.



Since then we have had the Settlement Deed ratified and signed at the ceremony held at Te Aute College. Although this Deed has had to be added to twice because of the urgency hearings involving our LNG, we have managed this process with the best of intentions and on 28 June 2017 the Heretaunga Tamatea Settlement Claims Bill was introduced to the sitting parliament. This was followed by the First Reading, which took place on 15 August 2017 and the Bill is currently before the Select Committee.

The Heretaunga Tamatea Settlement Trust is a board of 23 Marae Representatives who have been duly elected by a process set out in the HTST Deed of Trust. By 8 November 2017 the second phase of the election process will have been completed and the HTST Board will be a fully elected board.

As I look back on the past 18 months, I realise what an enormous step we have made and what a huge amount of work lies before us. For some of us, the journey to date has been about gaining a settlement and an apology from the government; for those who allowed their names to go forward to represent their Marae and Hapū for election on the HTST Board, they realise the hard work ahead in setting up an organization that understands the needs and wants of its thousands of members – they understand that although their marae and hapū nominated and elected them to their current position, they are members of a Trust that is bound by a Trust Deed and that the majority rule may not always reflect the viewpoint or stance of the marae/hapū they represent. Suffice to say that robust discussion takes place in all major decision-making and sometimes a legal opinion is pursued before final rulings are determined.



Initially, we applied for and received an 'on-account' settlement of \$5million. Although this money was targeted for specific projects, it has also allowed us to run and staff an office and to continue to partly fund He Toa Takitini towards the final settlement. All but one of the marae/hapū have received the \$100,000 distribution – the distribution to our marae/hapū was something that our people decided and discussed at the many Hui-ā-iwi and Hui-ā-Hapū held throughout Heretaunga and Tamatea. We listened to people talking about the post-settlement model they thought would work best for us and we have begun to implement your choices which will include a \$1million distribution to each of our marae/hapū upon full and final settlement. There has been widespread consultation with regard to a criterion for receipt of the \$1million. This has been collated and will be published for the AGM.

I would like to thank the Board members who work hard to achieve objectives and who have come such a long way in understanding the process of a Treaty Settlement and the impact of that on their marae/hapū. I would also like to pay tribute to a small office team who manage an ever-changing front, who are extremely flexible, very obliging, but most importantly a team who do their respective jobs well – thank you! Liz Munroe has continued to serve us to the best of her ability, often working long hours to achieve successful outcomes. It was very reassuring to hear the Minister of Treaty of Waitangi Negotiations making special mention of Liz and her exceptional ability to drive our claim...with passion and commitment – it has been a privilege to have travelled this journey with you Liz and I congratulate you for your humility and tireless strength.


Tēnā koutou katoa e ahu noa mai nei i Heretaunga, i Tamatea, i ngā tini whenua kua riro. Heoi, tēnā tātau katoa e whai tonu atu ana ki te pito o tēnei huarahi roa, ka mutu, kai te tatari tonu tātau. Nō reira rātau ki a rātau i ō rātau wā, tātau ki a tātau e hika mā, i roto o ēnei rā – ngā mihi nui.

It's been a long while and we are still waiting! But be assured all the big work is 'done and dusted'. After the Heretaunga Tamatea Deed of Settlement signing in September 2015, it remained to negotiate a way forward for Aorangi Māori Trust Board and gladly, in mid-July this year, their Deed of Settlement was signed at Oruawharo. We also dealt with three 'urgency' claims against our Deed – but those too have been settled. Our Bill has now been introduced to Parliament,



we have had a First Reading. We now wait for the new government to get its house in order and we expect the Third Reading and the Settlement process to be over by September 2018. You have been an extremely patient and gracious collection of hapū over this time where delay and frustration have been an ongoing challenge. Tino kino kē koutou - te 'iwi' o Heretaunga Tamatea.

It is appropriate to acknowledge our Taumata representatives, many of whom have been on this journey since the beginning. Firstly, let me then acknowledge Ngamoa Gillies who ably represented Waimārama Marae over the years until her recent passing. Nō reira e te kahurangi, moe mai rā. For our Board members, you have been, in my opinion, a Board who despite robust debate, have always managed to come up with a way forward from the situations we have found ourselves in. Look around, we can see others who have not been able to do so. Furthermore, each and every one of you has been able to robustly represent the interests of your marae/ hapū groups and those of our wider Heretaunga Tamatea rohe. Kāre i tua atu i a koutou e hika mā.



It is also appropriate to recall the length of time that our Lead Negotiator, Liz Munroe, has served us and the degree of skill she has brought to bear on our complex situation. My assessment is that we have done very well with our Settlement Redress and with the setting up of our PSGE. Liz has led us with great grace through some very trying times. Ko te mutunga kē mai o te wahine whakamīharo nei! Our team at He Toa Takitini and now Heretaunga Tamatea have also gone above and beyond the call of duty over the years and I thank you. Nā koutou tonu tā koutou nā mahi!

To our two other Chairs, Peter Paku and Roger Maaka, only by sitting in the Chair can the complexity of the job be appreciated and only by doing so, can the privilege of this service to the people be enjoyed. You did the hard yards and I got to wave the flag at the end. Kai a kōrua mō te ringa raupā!

The years ahead are of course crucial. The need to move from 'marae reps huddled together to chase the Claim' to become a group of 'astute and skilled developers of Hapū futures' is upon us. Some have chosen to leave the Board, well done – autaia tonu! Some will upskill and stick with the kaupapa – kai whea mai! And exciting new leaders of our community will move into the Board and will move us into the future.

What a journey He Toa Takitini has been. What a privilege!

# **KEY DECISIONS MADE ALONG THE WAY**

The journey to achieve a settlement has been bold as was the decision in 2008 to enter into direct negotiations with the Crown. Whilst unpopular in some sectors, the decision not to go to a Waitangi Tribunal Hearing was key, especially when we know that a Tribunal Hearing is a long process and there is absolutely no link between the resulting Tribunal recommendations and the agreed settlement quantum.

The journey was also lengthy, hamstrung significantly by the very limited funding provided by the Office of Treaty Settlements and the Crown Forestry Rental Trust. It was only ever "a contribution" in their words and many times the office was shut down in the course of the negotiations with staff being let go. The two Hui-A-lwi decisions in June 2014 to approve an overdraft facility were key, as it meant He Toa Takitini and the Negotiation Team could then drive the negotiation more forcefully. It also meant HTT could successfully defend four urgency applications, minimising the time required and associated costs.

The next key decision was to approve the post-settlement governance entity. Participation in the Ratification process exceeded 41%, trumping participation rates in local and central government elections, with 96% approval from participating voters. Our people are to be applauded and in return a review of the PSGE is to undertaken within two years of the settlement date.

Applause is also due to our people for agreeing to the Deed of Settlement. Similarly, the participation rate was 40% with 95% approval. Essentially, in the scheme of Treaty Negotiations, the Heretaunga Tamatea Settlement was the best deal achievable and being the 4<sup>th</sup> largest until recently, it is a good settlement.

Another two key decisions were the On-Accounts:

- 1. \$5 million On-Account: this allowed for an immediate distribution to the marae/hapū; and
- 2. \$45.5 million received on 9 March 2017: it meant Heretaunga Tamatea could continue its growth strategy for our marae/hapū, largely unaffected by the impending General Election 2017. It also secured a higher interest rate than the official cash rate of 1.75%, adding \$1.26 million to the asset base.

Whilst a bold question to ask of the Government, it proved difficult for Treasury to decline the request even though there was no precedent and the Bill had not been introduced into Parliament at that time.

Of all decisions, most key has been the continuing patience and support along the way that has been shown by the marae/hapū of Heretaunga Tamatea. For that we give you \$1 million each, as promised.

Finally, it is fitting to acknowledge the trust and loyalty shown in relation to the claims of Te Aute College and the Aorangi Maori Trust Board, when all that was offered in both the Agreement In Principle and the Deed of Settlement were simple promises to explore. Ka nui te mihi.

# WHERE TO FROM HERE?

There are two key processes ahead to note, where all members of Heretaunga Tamatea are encouraged to participate. These events will be widely notified. HTST office staff will call hui to offer assistance writing your submissions.

# MÃORI AFFAIRS SELECT COMMITTEE (MASC)

**December 2017:** MASC will call for written submissions on the Heretaunga Tamatea Claims Settlement Bill (the Bill). The submission period is usually open for one to two months.

**Feb/March 2018:** A hearing will be held to hear oral submissions on the Bill. The hearing is likely to be held within the Heretaunga Tamatea rohe.

April 2018: MASC will report to Parliament.

# **3rd AND FINAL READING**


The last step for the Bill to become law is the 3<sup>rd</sup> and Final Reading. This is likely to happen in August 2018.

The 3<sup>rd</sup> Reading will take place at Parliament in Wellington. Travel arrangements will be notified widely.

Unlike the 1<sup>st</sup> Reading, there is no limit on the numbers who can attend. Any member of Heretaunga Tamatea who wishes to attend will be given the opportunity to do so.


# MARAE/HAPÜ \$1 MILLION DISTRIBUTION CRITERIA

As at 31 March 2017, the criteria for the \$1 million distribution has been finalised, following a wide consultative development process that spanned eighteen months.


- The Marae/Hapū \$1 million Marae Distribution Criteria was unanimously approved by HTST on 31 October 2017

# **FUNDAMENTAL PURPOSE**

The \$1.1 million distribution proposal is by far the highlight for Heretaunga Tamatea, generating great excitement and optimism among our HTST trustees and our marae members as they go about their planning and preparations to receive the distribution. The fundamental purpose of the distribution is to grow Heretaunga Tamatea in all ways possible. Also it:

- 1. Recognises that the marae and hapū of Heretaunga Tamatea should benefit directly from the agreement reached with the Crown in the settlement of the historical Treaty grievances of Heretaunga Tamatea;
- 2. Provides for tino rangatiratanga and mana motuhake of the whānau, hapū, marae and people of Heretaunga Tamatea; and
- 3. Positions the marae and the hapū to influence and grow their people, the whanau, hapū and marae.

# **STAGE ONE**

The first distribution of \$100,000 is paid to prepare our marae/hapū to receive \$1 million. As at 31 August 2017, the first distribution has been made to 22 marae. HTST expects to make the distribution to the remaining two marae by December 2017.

# **STAGE TWO**

HTST plans to make the first \$1 million distribution in the 2017/2018 financial year. A copy of the criteria is included as a separate leaflet with this Annual Report.

- o Providing for influential Treaty-based arrangements with all local, regional and central government agencies


### Review of HTST Post Settlement Governance Entity Model


